Contractor shall be required to indemnify, defend, and hold harmless the Sedro-Woolley Chamber of Commerce and the City only to the extent claim is caused in whole or in part by negligent or intentional acts or omissions of the City. I have all permits, licenses, insurance, etc. required by the city, county, and state to operate a legal business. I am of legal age (18 years or more).
