There are no water hookups or electricity hookups available.** The hours of operation we require are 11:00am to 7:00pm. Hours beyond that is at your discretion. The fee is \$240.00.

Contractor shall be required to indemnify, defend, and hold harmless the Sedro-Woolley Chamber of Commerce and the City only to the extent claim is caused in whole or part by negligent or intentional acts or omissions of the City. I have all permits, licenses, insurance, etc. required by the city, county, and state to operate a legal business. I am of legal age (18 years or older).

In consideration for allowing me to participate, I agree to indemnify and hold harmless the Sedro-Woolley, the Sedro-Woolley Loggerodeo™, Chamber of Commerce and their agents, the City of Sedro-Woolley and their agents from expenses of whatsoever kind of nature, including attorney's fees incurred by reason of or in connection with participation in this event.
