Contractor expressly agrees to indemnify, defend, and hold harmless the Sedro-Woolley Loggerodeo™, the Sedro-Woolley Chamber of Commerce and the City for any claim arising out of or incident to Contractor's or any subcontractor's performance or failure to perform the contract. Contractor shall be required to indemnify, defend, and hold harmless the Sedro-Woolley Chamber of Commerce and the City only to the extent claim is caused in whole or in part by negligent or intentional acts or omissions of the City. I have all permits, licenses, insurance, etc. required by the city, county, and state to operate a legal business. I am of legal age (18 years or more).

In consideration for allowing me to participate, I agree to indemnify and hold harmless the Sedro- Woolley Loggerodeo™, the Sedro-Woolley Chamber of Commerce and their agents, the City of Sedro- Woolley and their agents, from expenses of whatsoever kind or nature, including attorney's fees, incurred by reason of or in connection with participation in this event.
